- Artist in residence program
- The James Castle House site was purchased by the city in 2015 and opened to the public in 2018 after 3-3.5 years or renovations. The home had been owned by someone other than the Castle family for about 20 years prior to the city purchasing it. During the renovation, they preserved what they could and added contemporary features. Eleven pieces of art were found in the walls. Those pieces were returned to the family trust, who had them repaired and then donated them to the city along with another 50 pieces of art.
- Castle is a very well-known artist. Most of his fame came after his death. He was born 1899 in Garden Valley, Idaho. He was born deaf and never learned to read, write, or use American Sign Language. He attended a school for the deaf that did not allow the use of ASL. His sister also became deaf later in life. The family moved to Star and then to Boise. The current homesite was once a 5-acre subsistence farm with a one room house. James was 32 years old living with his mother when his sister and her family moved into the home. The shed was his studio for about 32 years. During that time, he made thousands of pieces of artwork. His nephew attended art school in Portland and shared James Castle's art with a professor, which lead to art shows and sales. He then had his own "cozy cottage" space that his sister had built with some of the money from his sales. James Castle died in 1977. His family took very good care of him and encouraged his art.

- James Castle used found objects to make art. He is well known for soot and spit ink wash/charcoal material, which was initially developed out of necessity, but then became his preference. He was totally self-taught, including linear perspective.
- The museum has now been open for 6.5 years and is part of the Historic Artist Homes and Studios Association.
- Castle and his family developed "home sign" and he also used art for communication. He created his own alphabet and used it to create written works throughout his career. He also developed a cast of authors (characters with little portraits to which he would attribute his writings).
- The Castle House represents a rare connection between the practice to the place.
- The Castle Family Foundation is focused on organizing and archiving the collection.
- Story, Story night is going to be hosted at the James Castle House on September 19 from 7-9 p.m. All the storytellers are deaf.
- The next Artist in Residence Workshop is on September 21 and the artist's presentation will be on October 10.
